**NBT (nitro blue tetrazolium) Formulation:** NBT (50mg/ml) in 70% dimethylformamide.

**BCIP (5-bromo-4-chloro-3-indolyl-phosphate) Formulation:** BCIP (50mg/ml) in 100% dimethylformamide.

**Storage Conditions:** Store at 4°C or -20°C. See the Product Information Label for expiration date.

**Usage Note:** BCIP may precipitate during storage; warm to room temperature and mix to redissolve before use.

**Preparation of Substrates to Detect Alkaline Phosphatase:** For every 5ml of alkaline phosphatase buffer (100mM Tris-HCl [pH 9.0], 150mM NaCl, 1mM MgCl<sub>2</sub>), add 33μl NBT and 16.5μl BCIP. Add the NBT first, mix, add the BCIP and mix again. Use within 1 hour, and discard any unused solution.
